

## **2021 System Performance Measures**



What's the **average number of days** that people are experiencing homelessness?

- **76 days of homelessness** for people who stayed in Emergency Shelters or Safe Haven beds
- **days of homelessness** for people who stayed in Emergency Shelters, Safe Havens, or Transitional Housing
- **1,098 days of homelessness** for people who stayed in Emergency Shelters, Safe Havens, Transitional Housing, and Permanent Housing (prior to their Permanent Housing move-in date)



#### How many people exited programs to permanent housing destinations, then **returned to homelessness**?

# How many people served were experiencing homelessness **for the first time?**

979 people entered Emergency Shelters, Safe Havens, and Transitional Housing during the reporting period who had no prior enrollments in HMIS.

**1,803** people entered Emergency Shelters, Safe Havens, Transitional Housing, and Permanent Housing during the reporting period who had no prior enrollments in HMIS.

#### How many people who were experiencing homelessness **moved into** or **retained** permanent housing?

**331** people exited from Street Outreach programs **to permanent housing** (23% of SO exits)

720 people exited from Emergency Shelters, Safe Havens, Transitional Housing, or Rapid Rehousing programs **to permanent housing** (49% of ES/SH/TH/RRH exits)

**1,498 people** exited from Permanent Housing programs and **retained permanent housing** (97% of PH exits)

#### How many **people are experiencing homelessness** in Nashville?\*

**32%** of **stayers** in CoC-funded programs (people who had not yet exited by the end of the reporting period) increased their total income.

**54%** of **leavers** (people who had exited by the end of the reporting period) increased their total income.

### **HUD System Performance Measures**

HUD has developed the following seven system-level performance measures to help communities gauge their progress in preventing and ending homelessness. In order to encourage all local service providers to regularly measure and evaluate their progress in meeting the needs of people experiencing homelessness, HUD considers CoCs' System Performance data each year when awarding CoC funding through the CoC NOFO. The System Performance Measures can also be used locally to assess the system's functionality and to identify gaps in services. For CoCs to accurately assess their progress using these measures, they must ensure that their data are as complete and accurate as possible, from data entry to report generation. In order to fully understand and report on these metrics accurately, Nashville's CoC must continue to expand HMIS coverage among provider agencies.

**Measure 1:** Length of Time Persons Remain Homeless **Desired Outcome:** Reduction in the average and median length of time persons remain homeless

**Measure 2:** The Extent to which Persons who Exit Homelessness to Permanent Housing Destinations Return to Homelessness within 6 to 12 Months and within 2 years **Desired Outcome:** Reduction in the percent of persons who return to homelessness

**Measure 3:** Number of Homeless Persons **Desired Outcome:** Reduction in the number of persons who are homeless

**Measure 4**: Employment and Income Growth for Homeless Persons in CoC Program-funded Projects

**Desired Outcome:** Increase in the percent of adults who gain or increase employment or nonemployment cash income over time

**Measure 5:** Number of Persons who Become Homeless for the First Time **Desired Outcome:** Reduction in the number of persons who become homeless for the first time

**Measure 6:** Homelessness Prevention and Housing Placement of Persons Defined by Category 3 of HUD's Homeless Definition in CoC Program-funded Projects

Not applicable to Nashville, only measured in high-performing communities

**Measure 7:** Successful Placement in Permanent Housing **Desired Outcome**: Increase in the percent of persons who exit to an ES, SH, TH, or permanent housing destination.
